- The unfavourable scenario occurred for an investment between 31/12/21 - 30/12/22 (if you surrender after 1 year) and between 31/12/21 - 31/01/23 (if you surrender after 5 years).
- The moderate scenario occurred for an investment between 31/08/15 - 31/08/16 (if you surrender after 1 year) and between 30/09/14 - 30/09/19 (if you surrender after 5 years).
- The favourable scenario occurred for an investment between 31/03/14 - 31/03/15 (if you surrender after 1 year) and between 31/01/13 - 31/01/18 (if you surrender after 5 years).
